Guidelines on admission in Management Quota Seats and fee Structure for Self-

Financed Polytechnics for the Academic aYear 2013-14

In suppression of all the earlier orders on the subject noted above, the undersigned is directed to say that the matter of admission guidelines in Management Quota Seats and fee structure of VOCLET seats of Self-Financed Polytechnics for the academic session 2013-14 have been reviewed and after careful consideration of the matter the Governor has been pleased to accord approval to the following amendments / eligibility criteria:

(1) 75% of seats of the approved intake of the Self Financed Postechnics affiliated to the WBSCTE shall be filled up from the JEXPO'2013 rank holders on the basis of Centralized Counseling.

(2) 25% of approved intake will be the Manager en Quot seats and that will be filed up by the respective polytechnics from the candidates who have passed secundary or equivalent examination with English, Physical Science and Mathematics with 35% marks (without rounding up) in aggregate (excluding additional subject) and 45% marks (without rounding up) in Physical Science and Mathematics taken together OR any Jexpo,2013 rank with 35% marks (without rounding up) in aggregate (excluding additional subject).

(3) There is no Management Quota in case of lateral/direct Admission to the 2nd year of Diploma course in Self-

Financed Polytechnics.

(4) Fee structure for the 1st year admission will remain unchanged as in G.O. No. 528-TET(Poi)/VIIC-08/2009, dated the 29th July,2009.

(5) Tuition fee of students admitted through VOCLET-2013 will remain unchanged,

These guidelines will remain valid only for the academic session 2013-2014
