**ELIGIBILITY:** 1) Candidates must be Indian citizens.

2) Academic Qualification: Passed Madhyamik or equivalent examination with minimum 35 % marks in aggregate (without additional subject and without rounding up)

**APPLICATION:** The prescribed **Application Form is to be downloaded from the Council's website [www.webscte.org](http://www.webscte.org) from 03.06.2015** (Print out of the Application Form to be taken on both sides of a page).

**SUBMISSION OF FILLED-IN APPLICATION FORM:** The Application Form, duly filled-in, should be submitted in person or through messenger to any of the aforementioned Institutions on any working day [except Sundays and gazetted holidays] between 11.00 a.m. and 4.00 p.m. within **18.06.2015** along with **Rs.500/-** (Rupees five hundred) only in cash towards application fee. For Saturdays, submission time is from 11.00 a.m. to 1.00 p.m.

No document is to be enclosed with the application form. Following **original** testimonials will have to be produced by the merit listed candidates at the time of counselling and also at the time of admission.

(i) Mark sheet of Madhyamik or equivalent examination.

(ii) Medical Certificate obtained from Registered Medical Practitioner or Medical Officer.

An applicant should ensure that he/she satisfies the requirements relating to Educational Qualification, Physical Fitness etc. before submission of the filled-in application form. The candidature will be automatically rejected if the candidate does not fulfil these requirements. Application form will have to be filled-up properly and completely in all respects. ***No request for subsequent change in information, submitted by the candidate in the filled-in application form, will be entertained under any circumstances. The Council is not liable for refusal of admission to a candidate by the Institutions even after being merit listed for wrong submission of information by the candidate.***

**METHOD OF SELECTION:** For above mentioned course, there will be centralised Entrance Examination. Questions will be of MCQ type consisting of Mathematics (40 marks), Physics (20 marks), Chemistry (20 marks) and General Knowledge (20 marks). Questions will be of the standard of Madhyamik or equivalent examination. Information related to schedule of the Entrance Examination, issuance of Admit Cards and others will be notified in due course of time in the aforesaid website of the Council. Schedule of the Entrance Examination is tentatively in the **1<sup>st</sup>/2<sup>nd</sup> week of July, 2015.**

**PUBLICATION OF MERIT LIST:**

The Council will publish a consolidated Merit List which will be displayed in the **Council's website, [www.webscte.org](http://www.webscte.org)** but shall not communicate the result to any individual applicant. There is no provision for post-publication scrutiny or review. ***No Rank Card will be issued by the Council to the merit listed candidates.***

**ADMISSION:** Admission of candidates to the Institutions mentioned above will be made from the merit listed candidates through centralised counselling. Detailed information regarding the Programme of Counselling and other related matters shall be available in the Notice Board of all Institutes mentioned above after the publication of the merit list and also in the website of the Council at **[www.webscte.org](http://www.webscte.org)**.

**LEGAL JURISDICTION**

All disputes pertaining to admission of students under the above mentioned courses shall fall within the jurisdiction of Kolkata only.
