**Introduction:**

West Bengal State Council of Technical & Vocational Education & Skill Development is a Statutory Body formed under Government of West Bengal Act XXVI of 2013 under the Department of Technical Education, Training & Skill Development, Govt. of West Bengal.

This Council, branched into different divisions, is entrusted to regulate academic activities of the technical education at diploma as well as the technician level within the state on behalf of the Government of West Bengal. In its endeavor to realize the enshrined objectives, the Council has to conduct several examinations under its academic monitoring activity.

In order to smooth conduct of the exams, for distribution and collection of examination related confidential materials, Council hires vehicles for transporting the examination related materials escorted by teams and at least 2 security personnel in each vehicle for strict observance of the confidentiality and security aspect of the examination related materials.

The following examinations state-wide for the diploma in polytechnics, VII+ level & H.S. Vocational Courses in different VTCs and the NCVT courses in ITIs & JTSs, the details of route-charts and tentative schedules are detailed as under

- (B) Security Deposit (Including Earnest Money) : **5%** of total work value to be paid before (including Earnest Money) commencement of work
- (C) Performance, if any, to be Deducted from bills : T.D.S. as per I.T. rules in force
- (D) Period of work : The period of validity of the tender shall be one year from the date of the tender (as provided under details of Job).

In the event of e-filing, intending bidders are required to download the tender documents from the website: <http://wbtenenders.gov.in> directly with the help of digital signature certificate. Earnest Money to be deposited to the office of the West Bengal State Council of Technical & Vocational Education & Skill Development, **Karigari Bhavan**, Newtown, Rajarhat through **demand draft/pay order** drawn from any nationalized bank payable at **Kolkata** drawn in favour of **WBSCT&VE&SD**.

### **Job description:**

Route Chart provided are tentative based on historical data. However, the transport service is to be provided based as per the actual Route Chart provided by this Council at the time of actual exam job. The job consists of:

- a) Picking up of examination related confidential packets from the office of the Council or any other place in Kolkata as directed along with escorting team and security personnel.
- b) Dropping the confidential packets at the scheduled destinations, as indicated in the respective Route Chart.
- c) If required, collection of the confidential packets from the scheduled destinations, as indicated in the respective Route Chart.
- d) **If required, temporary arrangement of displacement / relocation of seats for providing additional spaces may be needed.**
- e) **The bidder has to agree to provide Vehicles for all the routes, part or selective offer only will not be accepted in any condition.**

### **General Conditions:**

Bidder should have ~

- i) Experience in providing similar service to state govt./Central Govt./ PSUs/any other public institution like school/college for similar nature of job.
- ii) Registration with R.T.A. for Commercial vehicle(s).
- iii) Service Tax registration.
- iv) Documental evidence of submission of Professional-Tax along with a copy of current Trade License and a copy of PAN.
- v) The bidder should be a title-owner of at the least 2 vehicles.
- vi) Vehicles should not be of earlier than year 2010 and should be in good condition. Registration number of vehicles with currency of Insurance / Road Tax and Pollution must be ensured
- vii) The tender Application form and all Non Statutory Documents (NSD) attachments thereto shall be submitted along with the bid with each page being consecutively numbered and duly signed by the bidder along with the seal of the office through online bidding.
- viii) Registration number of the title-owing vehicles with currency of Insurance / Road Tax and Pollution should be submitted along with the technical bid.
- ix) This tender document is not transferable. The work, if awarded, is not transferable.

Necessary supporting documents required for General conditions must be enclosed with the bids at the time of applying through On-line.

### **Special conditions of contract:**

1. In the event of any mechanical failure/breakdown of vehicle after its reporting duty, the contractor/service provider shall arrange for replacement by another commercial vehicle within one hour. Non-compliance will attract a penalty in the form of rescinding of the contract agreement and in the form of claims related to the costs incurred in the form of partial performance of the job by the selected bidder shall stand invalid.
2. In case of any accident resulting in loss or damage to property or life, the sole responsibility for any legal or financial implication would vest with the contractor / service provider. WBSCT&VE&SD(TED) shall have no liability what so ever.
3. The contractor / service provider is/shall be liable for any legal disputes/cases/claims that have arisen or may arise during the currency of the job contract in respect of vehicle provided for transport. The WBSCT&VE&SD(TED) shall not be liable for any loss, damages, etc suffered/to be suffered by the contractor / service provider or third party as the case may be.

4. The contractor / service provider shall also be liable for all fines, penalties, and the like of parking, traffic and other criminal offences arising out of or concerning the use of the vehicle during the period of transport and any toll charges or entry taxes payable locally and the contractor / service provider accordingly indemnifies the WBSCT&VE&SD(TED) against all such liability.
5. The contractor / service provider is/shall be responsible for compliance of all the laws/ rules regulations and Government instructions that are / will be applicable to and aimed to protect the interest of the employees/ workers engaged by it and shall ensure payment of all the statutory dues/ liabilities as may have arisen during the past or may arise during the course of performance of this contract.

### **Arbitration:**

In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to the sole arbitration of the **Chief Administrative Officer**, WBSCT&VE&SD or any other person appointed by him. In case his designation is changed or this office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the **Chief Administrative Officer**, WBSCT&VE&SD or by whatever designation such officers may be called (hereinafter referred to as the said officer). In the event of such arbitrator to whom the matter is originally referred to vacates his office on resignation or otherwise or refuses to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the **Chief Administrative Officer**, WBSCT&VE&SD shall appoint another person to act as Arbitrator in the place of outgoing arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the Arbitrator shall be final and binding on both the parties. Contractor will have no objection in any such appointment that the arbitrator so appointed is an employee of WBSCT&VE&SD(TED) or a government servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a WBSCT&VE&SD(TED) employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the arbitration and Conciliation Act 1996, or any statutory modification or re-enactment thereof or any rules made thereof.

The venue of arbitration proceeding shall be office of the **Chief Administrative Officer**, WBSCT&VE&SD, Kolkata or such other place as the arbitrator may decide.

If the contractor institutes any legal proceedings against the WBSCT&VE&SD(TED) to enforce any of its rights under this agreement it shall be in the legal jurisdiction of WBSCT&VE&SD(TED) at Kolkata and not the place where the contractor has his registered office.

### **Submission of the Tenders:**

All tenders must be submitted online as provided in Table below in compliance with Annexure detailing the scopes of work. Tenders will be opened in presence of such tenderers or their authorized representatives.

The tender is to be submitted in a Two Bid System.

**b) "BID B":**

Another folder as "Financial Bid" shall contain the financial bids (BOQ) with the base rate i.e. hiring Charges for trip-day-bustype-category wise rates per hour use of Vehicle inclusive of all applicable Taxes and any other charges to be quoted.

The bidder has to quote for all the trip-day-bustype-category wise hiring charge rates per hour use of Vehicle, failing which the bid shall be rejected.

For broken days of use of vehicle, the all inclusive hiring charge trip-day-bustype-category wise rates per hour use of Vehicle shall be calculated pro-rata.

In case of 1-day trips, there shall be a minimum payment of 4 hours all-inclusive charge.

**Rates of Hiring Vehicles :**

- i) Rates of hiring vehicle should be quoted per day of use of Vehicles –per hour.
- ii) Rate should be inclusive of all – fuel, all wages of driver and helper and all other charges etc.

**c) BID Evaluation:**

1. During the tender evaluation process, the "Bid A" will be opened first. Those tenderers having qualified for the essential requirements will be identified on the basis of the supplied documents. The **Tender Selection Committee / Purchase Committee** will evaluate the document-wise eligibility of the valid bidders in pursuance of the terms & conditions mentioned in the e-NIT for executing the deliverable service to the council during the tender period and then only in respect of those technically qualified bidders out of the valid bidders, the "Bid B" will be opened.
2. For the purpose of evaluation, following methodology shall be maintained
  - a) For each exam-wise job value shall be calculated based on the quoted trip-day-bus-type-category wise hiring charge rates per hour use of Vehicle for each bidder;
  - b) In the process, for each bidder the **consolidated sum** of exam-wise total job-values for each vendor shall be calculated.
  - c) **Technically valid bidder** having quoted all the trip-day-bus-type-category wise hiring charge rates per hour use of Vehicle with the lowest consolidated sum as stated in b) the preceding clause shall be treated as **the lowest bidder** in terms of their quote in "Bid B"; and
  - d) The job shall be allotted to **the lowest bidder** in "Bid B" in pursuance of the govt. norms.
3. **Decision of the authority of the Council shall be final in this regard.**

### Earnest Money:

- (a) Each tenderer must deposit **Earnest Money in the form of Demand Draft/Pay Order for Rs.50,000/- (Rupees Fifty Thousand)** only drawn in favour of “**West Bengal State Council of Technical & Vocational Education and Skill Development** ” payable at **Kolkata**, before opening of Bid-‘A’. The Earnest Money is to be deposited once for participation in the whole tender. A copy of the Demand Draft/Pay Order of the **Earnest Money Deposit** should be included with the documents submitted in “**Bid A**”.
- (b) The earnest money of the Tenderer is **liable for forfeiture** in case the Tenderer withdraws the tender as a whole or for any particular item at any stage after the opening of the tender, or **fails/refuses to enter into written agreement** for any or all of the items of its accepted tender **within the time specified when requested to do so/fails to furnish Performance Bank Guarantee within the stipulated time.**
- (c) The Earnest Money will be **refunded after finalization of the tender or within 3 (three) months** from the **date of opening of tender** against the specific prayer from the Tenderer.
- (d) The **EMD instrument** shall be returned to the **selected vendor** on payment of **Security Deposit** at the request of the selected agency, if considered by competent authority of this Council.

### Performance bank guarantee/Security Bid :

- i) **Security Deposit: 5%** of the respective of the specific job-value will have to be deposited as security deposit before execution of respective jobs for the fulfilment of the terms and conditions of the contract and is **liable to be forfeited for non fulfilment of the obligations under the contract.** The same will be refunded to the transport contractor / service provider with the final bill after the successful completion of transport services under the contract. The security deposit shall have to be paid by the selected bidder into the Council's account through **State Bank Collect scheme.** Necessary **guidance** shall be provided with issuance of the offer letter.
- ii) The ‘**Performance Bank Guarantee**’ will be **mandatory** for the successful bidders and will not be waived in any case.
- iii) The successful tenderer shall be required to furnish the ‘**Performance Bank Guarantee**’ equal to **5% of the value** of the estimated job-value. ‘**Performance Bank Guarantee**’ should be submitted within three working days from the date of issue of the offer.
- iv) ‘**Performance Bank Guarantee**’ should be submitted within three working days from the date of issue of work order.
- v) The ‘**Performance Bank Guarantee**’ will be liable to forfeiture as enumerated in penalty clause above.

### Payment terms and Conditions:

- i) Payment will be made within 30 working days of placement of the bill, after successful completion of the transport services under the contract each for separate examination.
- ii) For release of payment selected vendor shall have to submit a blank signed cancelled cheque along with bank particulars – Account name [must be in the name of the vendor], bank, branch and IF5 code of the branch under a covering letter for release of payment in the said account.

**Termination of contract:** The contract may be terminated without prejudice to any other remedy for breach of contract if the contractor fails to arrange transport as per the timings set out or if he fails to perform any other obligation under the contract.
