Sub : Criteria for filling up vacant Seats by rank holders of JEXPO/VOCLET in self financed Polytechnics in the State for the Academic Year 2016-17

In continuation to this Department Memo No. 544(2) -TET(Poly)/14A-04/2011 Dated: 14th June, 2016 the undersigned is directed to say that a guideline for admission to 1st year Diploma Engineering courses in self financed Polytechnics under Management Quota for the academic session 2016-17 was issued under this Memo.

It has been noticed that after completion of counselling process certain seats for JEXPO /VOCLET- 2016 in various self financed Polytechnics are lying vacant.

For extending the opportunity of students who have secured ranks in JEXPO /VOCLET- 2016, the Government has reviewed the matter and after careful consideration of the matter, it has been decided to accord approval to the Management of self financed Polytechnics to fill-up the vacant seats after issuing a notice in the Notice Board and / or their Websites as per the following criteria:

1. The first preference should be given to any valid JEXPO rank holders in order of the rank and pass in Secondary or equivalent examination with English, Physical Science / Science and Mathematics with 35% marks (without rounding up) in aggregate (excluding additional subject).
2. The next preference should be given to the District Rank quota students as per JEXPO rank.
3. The seats, if any remaining vacant after giving preference to the above candidates, may be filled up from amongst the candidates who have passed in Secondary or equivalent examination, with English, Physical Science/ Science and Mathematics with 35% marks (without rounding up) in aggregate (excluding additional subject) and 45% marks (without rounding up) in Physical Science / Science and Mathematics taken together.
4. VOCLET seats may be filled up amongst the VOCLET candidates.
5. Fee structure of the 1st year admission will remain unchanged as in G.O. No: 528-TET (Poly)/ 11C-08/2009 dated 29th July, 2009.
6. Tuition fee of students admitted through VOCLET - 2016 will remain unchanged.


